



# Two U.S. Soldiers Killed By Numaniyah IED Attack

BAGHDAD – The U.S. military says two American soldiers have been killed while conducting operations in southern Iraq.

In a statement, the military says the deaths occurred Friday in Numaniyah, Iraq when insurgents attacked their unit with an improvised explosive device. They were assigned to the 2nd Squadron, 3rd Armored Cavalry Regiment, Fort Hood, Texas.

# Taliban Frees A Battalion Of Their Soldiers From Military Prison: "About 100 Of Them Were Commanders — Four Of Them Former Provincial Chiefs" Escape Tunnel Took Five Months To Build

The Taliban statement said it took four and a half hours for all the prisoners to clear the tunnel, with the final inmates emerging into the house at 3:30 a.m. They then used a number of vehicles to shuttle the escaped convicts to secure locations.

KANDAHAR, Afghanistan - Taliban militants tunneled at least 480 inmates out of the main prison in southern Afghanistan overnight, whisking them through a 1,000-foot-long underground passage they had dug over months, officials and insurgents said Monday.

Officials at Sarposa prison in the city of Kandahar, the birthplace of the Taliban, say they only discovered the breach at about 4 a.m., a half hour after the Taliban said they had gotten all the prisoners out.

The militants began digging the tunnel about five months ago from a house within shooting distance of the prison guard towers.

It was not immediately clear whether they lived in the house while they dug. They meticulously plotted the tunnel's course around police checkpoints and major roads, the insurgent group said in a statement.

The diggers finally broke through to the prison cells around 11 p.m. Sunday night, and a handful of inmates who knew of the plan unlocked cells and ushered hundreds of inmates to freedom without a shot being fired.

A man who claimed he helped organize those inside the prison told The Associated Press in a phone call that he and his accomplices obtained copies of the keys for the cells ahead of time from "friends."

He did not say who those friends were, but his comments suggested possible collusion by prison guards.

"There were four or five of us who knew that our friends were digging a tunnel from the outside," said Mohammad Abdullah, who said he had been in Sarposa prison for two years after being captured in nearby Zhari district with a stockpile of weapons. "Some of our friends helped us by providing copies of the keys. When the time came at night, we managed to open the doors for friends who were in other rooms."

He said they woke the inmates up four or five at a time to sneak them out quietly. The AP reached Abdullah on a phone number supplied by a Taliban spokesman.

The Taliban statement said it took four and a half hours for all the prisoners to clear the tunnel, with the final inmates emerging into the house at 3:30 a.m.

They then used a number of vehicles to shuttle the escaped convicts to secure locations.

The city's police mounted a massive search operation for the escaped convicts. They shot dead two inmates who tried to evade capture and re-arrested another 26, said Tooryalai Wesa, the provincial governor.

But there was no ignoring that the Taliban had pulled off a daring success under the noses of Afghan and NATO officials.

"This is a blow," presidential spokesman Waheed Omar said. "A prison break of this magnitude of course points to a vulnerability."

At least 480 inmates escaped from Sarposa, most of them Taliban fighters, according to the governor of Kandahar province.

The Taliban said they had freed more than 500 of their fellow insurgents and that about 100 of them were commanders — four of them former provincial chiefs.

As the massive jailbreak suggests, the Afghan government remains weak in the south despite an influx of international troops, funding and advisers.

Kandahar city, in particular, has been a focus of the international effort to establish a strong Afghan government presence in former Taliban strongholds.

The 1,200-inmate Sarposa prison has been part of that plan.

The facility underwent security upgrades and tightened procedures after a brazen 2008 Taliban attack that freed 900 prisoners.

In that assault, dozens of militants on motorbikes and two suicide bombers attacked the prison. One suicide bomber set off an explosives-laden tanker truck at the prison gate while a second bomber blew open an escape route through a back wall.

#### Afghan government officials and their NATO backers have repeatedly asserted that the prison has vastly improved security since that attack.

There are guard towers at each corner of the prison compound, which is illuminated at night and protected by a ring of concrete barriers topped with razor wire.

The entrance can only be reached by passing through multiple checkpoints and gates.

An Afghan government official familiar with Sarposa prison said that while the external security has been greatly improved, the internal controls were not as strong.

He said the Taliban prisoners in Sarposa were very united and would rally together to make demands from their jailers for better treatment or more privileges.

The prison break weakens the argument that international troops are making good progress in handing over more responsibility for security to Afghan forces, which will eventually enable the coalition to leave. resident Barack Obama plans to start drawing down forces in July.

CASTALIA -- Family members say a northern Ohio native is among the victims of a suicide bomber in Afghanistan. They say he was one of 10 people killed on Saturday outside a military base.

Army Sgt. 1st Class Charles Adkins grew up just outside Sandusky and graduated from Margaretta High School in 1993.

The 36-year-old had served two tours in Iraq before he was sent to Afghanistan in November.

Family members tell the Sandusky Register that he was training members of the Afghan army. Military officials say the bomber was a sleeper agent who was wearing an Afghan army uniform.

Adkins is survived by his wife and five children who live in Clarksville, Tenn.

# U.S. Military Awards A \$2.76m Contract For Software To Create 500 Persons On Social Networks In Order To Secretly Influence Online Debate In Its Favour:

"50 Military Spies To Manage 10 Fake Identities Each"

The US military awarded a contract for software to create 500 fake personas on social networks in order to secretly influence online debate in its favour. The \$2.76m contract was won by Ntrepid, a Californian firm, and called for an "online persona management service" that would enable 50 military spies to manage 10 fake identities each.

The personas should be "replete with background, history, supporting details, and cyber presences that are technically, culturally and geographacilly consistent", a US Central Command (Centcom) tender document said.

It added: "Individual applications will enable an operator to exercise a number of different online persons from the same workstation and without fear of being discovered by sophisticated adversaries.

"Personas must be able to appear to originate in nearly any part of the world and can interact through conventional online services and social media platforms."

The project would be based at MacDill Air Force base in Florida, The Guardian reported. The contract was first revealed by The Raw Story, a US news website. It also called for internet traffic from the project to be "mixed" with traffic from outside Centcom to provide "excellent cover and powerful deniability".

If used against US citizens such "sock-puppetry" techniques, as they are known online, would bring legal fire on the military.

The MoD [UK Ministry of Defense] meanwhile said it could find no evidence that British forces was involved in Operation Earnest Voice, a \$200m anti-jihadism psychological operation, of which Centcom's "online persona management service" contract was thought to be part.

# Obama Ran Against Bush, But Now Governs Like Him:

#### "On One Major Policy After Another, President Barack Obama Seems To Be Morphing Into President George W. Bush"

#### WASHINGTON

He ran as the anti-Bush.

Silver-tongued, not tongue-tied. A team player on the world stage, not a lone cowboy.

A man who'd put a stop to reckless Bush policies at home and abroad.

In short, Barack Obama represented change.

But that was then.

Now, on one major policy after another, President Barack Obama seems to be morphing into President George W. Bush.

On terrorism, he criticized Bush for sending suspected terrorists to Guantanamo Bay, Cuba, and denying them access to U.S. civilian courts. Now he says he'll do the same.

On taxes, he called the Bush-era tax cuts for the wealthy wrong and lately began calling again to end them. But in December he signed a deal with Republicans to extend them for two years, and recently he called the entire tax cut package good for the country.

Indeed, some of the differences between the two presidents are measured in gray, not black and white as once seemed the case.

At the same time, some of the surprising continuity of Bush-era policies can be tied to the way Bush and events set the nation's course, particularly on foreign policy.

Among the ways Obama has reversed his earlier promises and adopted, extended or echoed Bush policies:

#### **TERRORISTS**

As a presidential candidate, Obama vowed a broad reversal of Bush's policies toward suspected terrorists.

Most pointedly, he said he'd close the prison in Cuba and try suspected terrorists in civilian courts, not in military tribunals.

"I have faith in America's courts," he said in a 2007 speech. "As president, I will close Guantanamo, reject the Military Commissions Act, and adhere to the Geneva Conventions. Our Constitution and our Uniform Code of Military Justice provide a framework for dealing with the terrorists."

Last month, he changed course, saying he'd keep Guantanamo Bay open, and would try Mohammed before a military court.

The reversal, said Rep. Peter King, R-N.Y., the chairman of the House Committee on Homeland Security, "is yet another vindication of President Bush's detention policies by the Obama administration."

Echoing Bush, Obama's also asserted that he has the power to hold suspected terrorists without charges or trial, and that he has the power to kill U.S. citizens abroad if his government considers them a terrorist threat.

#### **WAR POWERS**

During his campaign, Obama signaled that he'd be far more circumspect than Bush was in using military power. He did say he'd send more troops to Afghanistan, which he's done, and that he'd attack al Qaida terrorists in Pakistan, which he's also done.

But he opposed the Iraq war from the start, and said he didn't think the president should wage war for humanitarian purposes or act without congressional approval, absent an imminent threat to the U.S.

"The president does not have power under the Constitution to unilaterally authorize a military attack in a situation that does not involve stopping an actual or imminent threat to the nation," he told The Boston Globe in 2007.

"In instances of self-defense, the president would be within his constitutional authority to act before advising Congress or seeking its consent. History has shown us time and

again, however, that military action is most successful when it is authorized and supported by the legislative branch. It is always preferable to have the informed consent of Congress prior to any military action."

On March 19, the U.S. attacked Libya on humanitarian grounds, absent any threat to the U.S. and without approval from Congress.

It took only a few days for the House of Saud to force the Gulf Cooperation Council (GCC) to toe the new hard line: we are the top dog; there's no room for democracy in the Gulf; sectarianism is the way to go; our relationship with Israel is now strategic; and Iran is to blame for everything.

The "Persian conspiracy" is the key theme being deployed by the hefty Saudi propaganda machine especially in Bahrain and Kuwait.

Israeli hawks, not surprisingly, love it.

There's plenty of flower power - or downright lunatic - rhetoric in the Israeli press about a "strategic alliance" between Tel Aviv and Riyadh, "similar to the one between the Soviet Union and the US against the Nazis". And guess what - Obama is to blame for it.

Without this strategic alliance, according to the Israeli narrative, the whole Gulf will fall "victim of a nuclear Iran", and the Obama administration won't lift a finger to save anybody. Obama is vilified as someone who "only confronts and abandons allies", while emboldening "evil" Syria and Iran. It's a narrative straight out of the Loony Tunes.

Trying to understand the stakes, Rupert Murdoch's Wall Street Journal got it all backwards, blaring there's a new Cold War between Saudi Arabia and Iran. That's what you get when you regurgitate PR by "Saudi officials".

It's the House of Saud counter-revolution against the Great 2011 Arab Revolt - condoned by the US - that has shattered America's "credibility on democracy and reform".

All this while the "traditional security arrangement" with Washington is not even working anymore.

The House of Saud is not stabilizing global oil prices; by refusing to increase production, it will let it reach \$160 a barrel-levels quite soon.

And meanwhile the White House/Pentagon keeps protecting that medieval bunch that were the first to recognize the Taliban in the mid-1990s, and whose billionaires finance jihadis all across the world.

The Gulf political midgets are now in the process of being homogenized - and kept under a leash - by House of Saud force.

Those Gulf kings and emirs may preserve their golden thrones - for now.

But expect plenty of cultural and religious violence ahead; plenty of nasty tribalism and sectarian wars, with no possible political evolution and no possible development of a modern civil society.

No surprise; fear and loathing are embedded in this reactionary House - an axis of multiple evils in itself that should only deserve a shallow grave in the desert sands.

DETROIT – In an interview with VOD, Ashley Matthews, 17, described the heroic student-led occupation of her school, Catherine Ferguson Academy on April 15.

She spoke of the wholehearted support the young mothers received from the community, as well as the vicious physical and verbal brutality police visited on them during their arrests.

She said two toddlers, there with their mothers, watched the events.

"When I came home, my mom and step-dad watched us on the news," Matthews said.

"My mom broke out in tears when she saw how the police treated me. She told me, 'I'm so proud of you.'

"This was the most joyful moment of my life. I was so flabbergasted by all the support and I felt so much pride because I actually stood up for something I believe in."

Catherine Ferguson is a Detroit Public School for teens with children, or who are expecting.

It provides special support services to help them complete their education and go on to college. It received broad publicity last year for the urban farm the students themselves created in the surrounding area.

It is the only school of its kind in the country, but it is on the list of almost 60 schools that DPS czar Robert Bobb, board chair Anthony Adams, and their state cronies, have slated for the chopping block this June, either through closure, merger or charterization.

Matthews said she has a two-year-old daughter, Breanna.

"The girls bring their kids to school because we don't have anyone else to watch them," said Matthews. "What else are we going to do? Ninety percent of our students graduate, and most of them go on to two and four year colleges. Our principal tells us 'smart mothers make smart children."

She said she is four classes away from graduation, but does not know if the students who sat in will be allowed back.

She said she decided they needed to fight to save their school, and approached the organization By Any Means Necessary (BAMN) for support.

"The day before, I packed up all my stuff, my clothes and food, because I thought we were going to stay for a week," Matthews said. "I left my daughter with my mom and dad. We were inside making signs and calls, going on Facebook, and putting stuff up in the windows. We hooked up speakers in the windows so we could voice our demands."

She said she was "surprised" when she saw how many people demonstrated outside in their support.

She said the supporters passed lasagna through the windows, but that they didn't even get a chance to eat it because the police got there first.

Supporters at first blocked numerous police cars from entering the school's back lot.

"When we heard the police were coming, we ran to the library as fast as we could and barricaded ourselves in there. The police knocked on the window, and before we knew it, they busted open the library door.

"We all got in a line and held hands. We took a vote because we wanted to be democratic and we decided not to leave. We chose to stick together, we came together and we were staying together. We were chanting, 'Whose schools? Our schools!'

"The whole time I was recording everything on my phone."

She said the cop who arrested her, a Detroit police officer named R. Brown, saw that she was recording the events and snatched the phone away.

She said Detroit Public Schools officers also took part in the attacks.

"I had sat down, and he yanked me up and slammed me down on my stomach on the floor," Matthews said.

"All the girls went berserk, telling him to get off me, but he was just wiping up the floor with me. He pressed his thumbs in my neck, and he tightened the handcuffs so hard that I have bruises there. I cried at first but then I made myself stop."

Matthews said she weighs only 100 lbs. and is often mistaken for being much younger because she is so small.

"The officer pushed me up against the police car, with my face against it, and put me in it," Matthews said. "They police didn't read us our rights even though they told us we were under arrest.

"Then they were playing 'good cop, bad cop,' asking, 'does your mom know you're going to jail?' I told them 'She knows, I'm fighting for my education, and I want a lawyer.' I wouldn't talk to them any more after that."

But Matthews said the police "verbally assaulted" them the whole way to the Eighth Precinct at Schaefer and Grand River. "All the officers were so rude to us you would have thought we had killed somebody," she said. "They asked us, 'do you have money, because you're going to be in jail all weekend.' They told me it was good I'm 17, because I would have to go on the 'big block' and I'd better not be talking that 'education stuff' there. They were so mad because it was females standing up. But we have the right to fight for our school, and we were non-violent."

She said the students felt absolutely "degraded" by the treatment they received from the police.

The students, represented by attorney Joyce Schon, were released that evening from the garage in the precinct, where they were forced to sit during their detention. During their arrests, their cell phones were taken, and many left without their shoes or jackets because the police would not allow them to get them.

Matthews said she received a ticket for "trespassing and being in the school after hours."

She said they plan to go back to get their possessions at the school this week.

"We ran out the jail to so many people hugging us, and telling us how proud they were of us," Matthews said.

"It's all over You Tube and Facebook now, and I hope everyone sees how the police treated females in my school," Matthews said.

"All my friends were contacting me on Facebook when I got home and asking what I got arrested for. It's time for all of us to stand up, it's our future. We can't find another school that does what Catherine Ferguson does. I am thankful to BAMN and our supporters because they truly showed us we do have a sense of hope, that there is something you can do about what happens."

She said her mother was a single mom too, and taught her to be strong, to do the best she could.

"Robert Bobb doesn't understand how we have to work hard to get an education to get to where we want to go, because he never had to do it," Matthews said.

"The fight's not over, not as long as any school is on that list," she said. "We are going to fight in a respectable, peaceful way for my school and for every school. I owe it to myself, to my classmates, to my daughter, to my mom and dad. I still love my school, and the Detroit Public Schools, and I am a proud citizen of Detroit."

#### Detroit SWAT Team Assaults African American Mom Who Refused To Drug Her Daughter:

"Child Protective Services Called In The Police To Aid In Their Kidnapping Of A 13-Year-Old Daughter From An African American Mother Who Refused To Medicate Her With Dangerous Psychiatric Drugs"

A SWAT team was then called in, carrying semiautomatic rifles and sniper gear. A 12-hour standoff ensued.

The real criminals in this case are the CPS workers. They should be brought up on attempting kidnapping charges as well as a criminal conspiracy to commit kidnapping.



Mike Ratte Nearly Lost His Seven-Year-Old Son Into Michigan's Foster-Care Gulag After Mistakenly Allowing The Child To Take A Sip From A Beverage Called Mike's Hard Lemonade During A Tigers Game

Mike Ratte nearly lost his seven-year-old son into Michigan's foster-care gulag after mistakenly allowing the child to take a sip from a beverage called Mike's Hard Lemonade during a Tigers game in 2008.

Ratte, a professor of archeology at the University of Michigan, didn't know that the product contained alcohol.

Since the sign advertising the drink described it only as "Mike's Lemonade," Ratte assumed that it was merely an overpriced soft drink.

Leo took a sip of the beverage, immediately found it distasteful, and place the bottle on the floor near his bleacher seat.

Shortly before the game ended a Comerica Park security guard waddled over, picked up the bottle, and asked Ratte if his son had been drinking from it.

Although Reed was puzzled by the question, he replied in the affirmative. His puzzlement mutated into alarm when he was told that the "lemonade" was actually an alcoholic drink.

The guard demanded that Ratte and his son remain seated while a scrum of his buddies assembled to escort them to a police substation located in the stadium.

When questioned by the police, Ratte admitted -- once again -- that Leo had taken a swig of the drink, repeating as well his insistence that this was an innocent mistake.

Anybody burdened with even a particle of common sense would recognize this as the truth.

If Mike Ratte were perversely determined to get his son drunk, would he do so in public?

If questioned about this, would such a person admit that his son had sampled the forbidden libation?

Anybody capable of making an EEG needle twitch would recognize that this was an honest mistake, not a crime.

But this didn't prevent the police from doing what they are programmed to do in such circumstances, which is to use any available pretext to kidnap the child.

As described in a civil complaint filed on behalf of the family, Mike and Leo were forced to take an ambulance ride to a nearby hospital, where Leo was forced to endure a blood test that confirmed the absence of alcohol in his body.

While his son was being needlessly bled and perforated, Mike was taken to a separate room and questioned by Officer Celeste Reed of the Detroit Police Department's Child Abuse Division.

This wasn't an investigation; it was a dilatory maneuver. Reed was simply waiting until the child-snatchers had worked out the details of the abduction.

When she finally acknowledged to Ratte that she and her comrades were going to steal his son, Reed played the Nuremberg Defense card, blaming a superior who was "pushing this case to impress her new boss."

Once Leo was in custody, however, Reed took the initiative, perjuriously claiming in her report that officers had "observed (Leo) to be intoxicated."

Leo was sequestered from his family and put into temporary foster care while the CPS bureaucracy labored to find some way to make their abduction permanent.

The "referee" assigned to the case announced that she would keep it open for a week.

However, Mike and his wife -- unlike most of the families victimized by the childsnatchers -- were people of means and influence. With the help of a capable attorney they were able to free their son after a mere two days' captivity.

"Class has something to do with the fact that the child was only in care for two days," points out Don Duquette, a law professor at the University of Michigan and director of the university's child advocacy center said.

"If you're not sophisticated, the system isn't set up to give you very much of a chance to work against the ritual that's ordinarily done."

That ritual can commence at any time, for any reason. And any family can be selected as sacrificial victims.

All that is required is the conjunction of an anonymous complaint and a willing bureaucrat.

The kidnapping of Leo Ratte occurred because his father made a trivial mistake involving a government-restricted mood-altering substance that inflicted no measurable harm on the child.

Unless a parent is a person of means and influence, like Mike Ratte, active resistance may be the only way to keep his child or children from disappearing into the CPS Archipelago once the family comes to the attention of the child-snatchers.

Ideally, this would mean pro-active measures to conceal a targeted child, or to provide for the child's escape in the event the child-nappers arrive.

The family of Elsie Wenzel, a beloved school lunch lady who died at age 71, gathered for a memorial service at a funeral home in Hamilton (a small town near Trenton) on April 15.

Charles Wenzel, one of her grandsons, "had ... something like a seizure," related Elsie's widower, Edward, in an interview with The Trentonian.

The family called 911 to summon the paramedics.

Unfortunately, if you call the paramedics, the police are part of the package deal, whether they're wanted or not -- and they have an unfailing talent for making matters worse.

When Charles had another convulsion, he committed the unpardonable offense of defiling one of the sanctified bully-boys through physical contact. This constitutes "battery on an officer," and so the offended cop and several of his boyfriends attempted to handcuff Charles while he was lying on the ground receiving medical treatment.

"We didn't call you for this!" exclaimed a witness as several other people, including a granddaughter of the deceased, tried to intervene to protect Charles from the criminal assault.

The officers responded by pepper-spraying the mourners and throwing several of them -- including Edward's middle-aged granddaughter -- to the ground.

Apparently the funeral parlor was located near a donut shop, because within seconds at least a dozen police vehicles were on the scene.

One of Elsie's sons, who was to be a pallbearer at the funeral, was jumped by "seven or eight" of the armed tax-feeders and thrown to the floor of the funeral parlor, Edward Wenzel reported.

Another eyewitness who drove by the scene was alarmed to see police swarming four other prone, helpless men.

By one account, at least a half-dozen of the pallbearers were arrested to sent to the hospital as a result of gang violence by the police.

When police attempted to "escort" him from the chapel, Edward Wenzel refused; if they had laid hands on the bereaved elderly widower, an authentic riot might well have ensued.

As I've pointed out before, a police officer who actually intervenes to prevent criminal violence by a professional associate can expect to be cashiered immediately.

The criminal offender himself, by way of contrast, can expect a lucrative paid vacation while the local police union spares no effort to preserve his job.

There was a time, not that long ago, when it was possible for Americans to avoid contact with the police, and the police were trained and expected to leave people alone.

Now, however, police are permitted and encouraged to behave like packs of lupine predators, eager to exploit any opportunity to inflict themselves on the helpless.

In police states of the kind Washington has supported in Egypt, Tunisia, and elsewhere in the region, people have been willing to endure a great deal of abuse as long as there was some reasonable expectation that they would be able to feed themselves.

It's not surprising to see that forbearance evaporate in the heat of the ongoing economic meltdown, which has left many people without the means to feed their families.

The triggering incidents that set off revolutions in both Tunisia and Egypt were episodes of casual, arrogant abuse by police officers who considered themselves to be imperviously clothed in official privilege.

Incidents of that kind are becoming more commonplace here in the putative Land of the Free, and the debt-prolonged illusion of prosperity that has long anesthetized public sensitivities is coming to an end.

Once again, it's not difficult to imagine a situation in which someone, somewhere is going to be pushed too far by an officious prig in a government-issued costume, an atrocity will result -- and then all hell will break loose.

Given the perverse ingenuity police display in arranging opportunities to impart such abuse, this could happen nearly anywhere, at any time.

Meanwhile, those of us who belong to the productive class should avail ourselves of every opportunity to share the following message with representatives of the State's coercive caste:

We don't need you.

We don't want you.

We don't respect you.

We won't tolerate you much longer.


